

# **GORILLA FINGERS PRIVACY POLICY STATEMENT**

Gorilla Fingers is committed to safeguarding your privacy online. Please read the following policy to understand how your personal information will be treated as you make full use of gorillafingers.com. This policy may change from time to time so please check back periodically.

## **What personally identifiable information is collected from you?**

GorillaFingers.com collects information in several ways from different parts of our web site. Some personal information is gathered when you register. During registration, we ask for your name and email address. The system will also ask for your city, state, and telephone number. This information is used solely to assist you in navigating the system by automatically filling in certain forms with your information so that you don't have to continually re-enter it. Once you register you are no longer anonymous to gorillafingers.com. You have a username and are able to take full advantage of the many offerings of gorillafingers.com.

In addition to registration we may ask you for personal information at other times. If you contact us, we may keep a record of that correspondence. Every page within gorillafingers.com includes a link to this Privacy Policy.

## **How your information is used?**

The primary goal of Gorilla Fingers in collecting personal information is to provide you, the user, with a customized experience and to assist your navigation throughout gorillafingers.com.

## **Who is collecting your information?**

When you are asked for personal information on gorillafingers.com, you are sharing that information with Gorilla Fingers alone, unless it is specifically stated otherwise.

## **With whom your information may be shared?**

As a general rule, Gorilla Fingers will not disclose any of your personally identifiable information except when we have your permission or under special circumstances, such as when we believe in good faith that the law requires it or under the circumstances described below. Please see the Terms of Service or Use Agreements for each of our

products and services for more detailed information about how your personal information may be shared.

Gorilla Fingers may disclose account information in special cases when we have reason to believe that disclosing this information is necessary to identify, contact or bring legal action against someone who may be violating the Terms of Service of the gorillafingers.com or may be causing injury to or interference with (either intentionally or unintentionally) the rights or property of gorillafingers.com, other users of gorillafingers.com, or anyone else that could be harmed by such activities. Gorilla Fingers may disclose or access account information when we believe in good faith that the law requires it and for administrative and other purposes that we deem necessary to maintain, service, and improve our products and services.

#### **What choices are available to you regarding collection, use, and distribution of your information?**

If you choose not to register or provide personal information, you can still use most of gorillafingers.com, but you will not be able to access areas or use features that require registration.

Gorilla Fingers does not sell or rent user information to anyone. We will notify you at the time of data collection or transfer if your data will be shared with a third party and you will always have the option of not permitting the transfer. If you do not wish to allow your data to be shared, you can choose not to use a particular service.

#### **How you can access, update or delete your information?**

We will provide you with the means to ensure that your personal information is correct and current. You may edit or delete your user profile at any time graphic provided by the system once you are logged in. Once you have logged onto the system during a given session, wherever you go on gorillafingers.com, your information will stay with you until or unless you click on the "Logoff" link, which is accessible from within the "Account Profile" screen.

If you are a previously registered user and you have lost or forgotten your password, you may obtain it by email by using our "Forgot Password" feature. Click the button on any login page to request that your password be emailed to you. We cannot provide your password by any other means.

#### **The kind of security precautions that are in place to protect the loss, misuse, or alteration of your**

Other than the administrator of gorillafingers.com or other authorized personnel of Gorilla Fingers, you are the only person who has access to your personal information. Your user registration is password-protected to prevent unauthorized access.

We recommend that you do not divulge your password to anyone. Gorilla Fingers will never ask you for your password in an unsolicited phone call or in an unsolicited email. As an extra security precaution, you may want to logoff once you have completed a session in gorillafingers.com. This is to ensure that others cannot access your personal information and correspondence if you share a computer with someone else or are using a computer in a public place like a library or Internet cafe.

As a result, while we strive to protect your personal information, Gorilla Fingers cannot ensure or warrant the security of any information you transmit to us or from our online services, and you do so at your own risk. Once we receive your transmission, we make our best effort to ensure its security on our systems.

## **How eTractorConnect.com protects children's privacy?**
